

Executive Summary for the 2016 Form 990

In 2015, Brother Wolf launched our Capital Campaign to build Brother Wolf Animal Sanctuary. Because of the capital campaign launch in 2015, total donations were significantly greater (16.8%) in the launch year as compared to 2016. [ref 2016 990, Line 12]

In 2016, Brother Wolf's Rapid Response team responded with search and rescue support to an unprecedented five major natural disasters (2 major floods and 3 major wildfires). For the first time in our history, over half the operations year included support work in response to natural disasters. To accomplish this support without interruption to core rescue and adoption operations, we increased staffing expenditures by 30.1% over 2016. [ref. 2016 990, Line 15]

To cover increased expense due to Rapid Response work as noted above, Brother Wolf secured supplemental pledges from major donors totaling approximately \$750K. These pledges were fulfilled after close of year and booked 2017 to cover the increased net expenditures of \$247,680 [ref. 2016 990, Line 19].

The surplus balance of approximately \$500K has been deposited into a Brother Wolf savings account, available to support routine and/or Rapid Response operations expense as needed.

Adoption and Sheltering Program:

Each year, we are able to save more lives because of the life-saving programs we have put into place. Such as adoption counseling (approx. 3,500 animals adopted), fostering (over 400 animals in care daily in a network of 900 foster homes), transports to our rescue partners (over 760 animals), and our Community Cat program (755 cats spayed/neutered). In 2016, with just these live-saving programs alone nearly 6,000 animal lives were rescued. Our Pet Retention programs, which work to keep animals in loving homes and out of the shelter system, saved an additional 800+ lives. Our adoption center is open to the public 7 days a week, 365 days a year and houses up to 140 ready-to-adopt animals on any given day. Very often, we rescue special needs animals who have been neglected, abandoned, or turned away from other shelters. This includes cats with Feline Immuno-virus (FIV) or Feline Leukemia Virus (FeLV),

dogs with heartworm disease, under socialized animals, senior animals, etc. Though we are hands-on with the most challenging and traumatized animals in our region, Brother Wolf only euthanizes animals who are irremediably suffering due to medical issues or are too aggressive with no hope of rehabilitation. We believe that each and every animal life matters and our core ethic of Uncompromised Compassion guides our daily work. Our No-Kill vision extends beyond our own community. That is why Brother Wolf implemented the No-Kill Community Development Initiative (NKCDI.) Our NKCDI exists to help some of the most impoverished areas of the Southeast cultivate community support. Allowing each area to build their own No-Kill community and implement these life-saving programs. With the introduction of five new chapters, we saw a significant decrease in euthanasia rates throughout those communities almost immediately! In 2016, our chapters included communities in McDowell, Henderson,

Disaster Recovery and Rapid Response

Our Rapid Response Program is deployed to assist with sudden disaster in other communities. Brother Wolf has provided immediate response and recovery efforts throughout the Southeast whenever possible. In 2016, we responded to three natural disasters in a very short time period. Brother Wolf raised the flood-ravaged Livingston Parish community in Louisiana, reassured and fortified the animals after Hurricane Matthew tore through the Carolinas, and examined animals from the devastating wildfires in North Carolina and Tennessee. Our disaster response comprises of many staff, volunteers, and donated resources. These staff and volunteers remain in the disaster areas for weeks after. humble comfort to animals that are in distress. With the aid of our resources and manpower, over 1,000 animals were saved and many animals were given a new lease on life after losing everything they had during these natural disasters.

Transport Program

Our Transport program saved over 750 dogs & cats in 2016. Dogs & cats from overcrowded shelters in the southeast are relocated to our partner rescues in the northeast. These rescues have a high demand for adoptable animals in their areas and communities, which provides better chances at forever homes for many more animals. Before transport, all animals are spayed/neutered, microchipped, and vaccinated against many life-threatening illnesses. Each animal also goes through individual blood tests for species specific diseases, and receives treatment for parasites, fleas, and ticks. Each animal also has a behavior evaluation completed by our Brother Wolf Behavior Team. We only send the healthiest (of both body and mind) into our Transport program to ensure they'll get adopted into a forever home, quickly. Our transport is an instrumental part of relieving the stress of crowded shelters and helping achieve our No-Kill mission around our Asheville location and our Brother Wolf Chapter No-Kill communities.

Sanctuary Program- (kick off for the transition year)

The Brother Wolf Animal Sanctuary is located over 80 acres of pastures and forest in The Brother Wolf Animal Sanctuary is located over 80 acres of pastures and forest in Leicester, NC, just 25 minutes from downtown Asheville. The Brother Wolf Sanctuary will provide a peaceful place for animals to heal, learn, rehabilitate, and play as they make their journey to being available for adoption to a loving home. Our plans include an On-site Veterinary Clinic, a Dog Village and Dog Park, Cat Village and Cat Cafe, Welcome Center, Educational and Learning Center, a Memorial and Reflection Garden, and also Guest Cabins. The clinic will help us significantly cut down on current medical & surgical costs by bringing most veterinarian services into our home clinic. Providing our animals comfort and a low-stress during their clinical visits. The Dogs can enjoy the Dog Village for the lazy slumbers and the Dog Park to release and run around. Our cats will enjoy days of laziness in the Cat Village or visit the Cat Cafe for hours of entertainment and play. Our many habitats will also provide shelter for our various farm animals that make our Sanctuary home. The Sanctuary will be an educational resource for the communities and areas youth and also many visitors from all over the world. All with the desire to learn about our responsibilities we have to our animals, nature, and to be able to connect with the animals and be inspired to live more compassionate lives. Our sanctuary is an integral part in helping all of us reach our No-Kill vision. A time when our community embraces our core ethic of uncompromised compassion.

No-Kill Community Development Initiative-

Our No-Kill vision extends beyond our own community. That is why Brother Wolf implemented the No-Kill Community Development Initiative (NKCDI.) Our NKCDI exists to help some of the most impoverished areas of the Southeast cultivate community support. Allowing each area to build their own No-Kill community and implement these life-saving programs. With the introduction of five new chapters, we saw a significant decrease in euthanasia rates throughout those communities almost immediately! In 2016, our chapters included communities in McDowell, Henderson, Rutherford, Marion, SC and Dickenson, VA. Our NKCDI was started because we were asked every day to take animals from these particular communities in-order to save them from being euthanized. We knew, by taking these animals and not digging deeper into the root of the problem, we were just placing a Band-Aid on a much bigger issue. Brother Wolf understood that if, we were going to continue to help, we would do so strategically. We created a path for long-term sustainable change. A solid foundation for each community to grow and nurture their own No-Kill community. We provided financial support to help lay

the groundwork for these life-saving programs. Brother Wolf has continued to support each chapter, as each chapter has become completely self-sustainable in their own No-Kill community. Part of our strategy is to teach each chapter how to maintain a sizable adoption center, to do high volume adoptions, if feasible in that community. How to recruit and train volunteers, build a compassionate foster network, and work with individuals and businesses to cultivate support of the No-Kill mission. Also, each chapter works directly with animal control and the municipal shelters on a daily basis to obtain the locations of animals in our need. And, most important, Brother Wolf helps work with individuals in the community to help keep their pets happy and healthy and in their homes and out of the shelter system all together.
