2018 990 Cover Letter

In February 2019, a leadership transition took place at Brother Wolf Animal Rescue. The organization was at a critical point and swift changes needed to be implemented to ensure sustainability for the future.

With a commitment to transparency, Brother Wolf announced in spring 2019 that the organization was facing a one million dollar funding gap and had ended 2018 with a large deficit. If not for the generosity of a donor who left a one million dollar bequest at the end of 2017, Brother Wolf would not have made it through the 2018 fiscal year.

To address these significant challenges, we implemented budget and staffing cuts across the organization, sold off assets, and worked to increase donations. We made sure that every penny was spent wisely and in line with our core mission.

To ensure that this situation does not occur again, we also built a professional board of directors for governance, instituted fiscal management procedures, and developed a leadership team who is held accountable for income and spending.

Brother Wolf Animal Rescue's 2018 990 was finalized in October 2019 by a team of dedicated professionals who redid all of the organization's 2018 accounting to ensure its accuracy.

We are turning things around. We have dramatically decreased our anticipated deficit and have just ended three months in a row with positive cash flow.

Running a nonprofit like a business is a necessity. This is done in service to the animals who depend on us, the donors who generously give their own resources to us, and a community of supporters who believe in us. Brother Wolf will impact the lives of 9,000 animals in 2019. This lifesaving work is critical.

Thank you for being a part of our recovery, our new beginning, and our exciting future. Together we save lives.

Adoption and Sheltering Program

Brother Wolf Animal Rescue's adoption and sheltering program saves thousands of lives per year. In 2018, 2,729 animals were adopted out into homes. This is made possible in part by our dedicated foster homes. At any given time in 2018, Brother Wolf had over 200 animals in foster care being cared for by a network of hundreds of volunteer foster homes. Our Pet Retention program works to keep animals in loving homes and out of the shelter system; affecting an estimated 1,000 animals in 2018. Our adoption center houses about 100 ready-to-adopt animals on any given day. Very often, we rescue special needs animals including cats with Feline Immuno-virus (FIV) or Feline Leukemia Virus (FeLV), dogs with heartworm disease, under socialized animals, senior animals, and animals

struggling with behavioral issues. Brother Wolf only euthanizes animals who are irretrievably suffering due to medical issues or are too aggressive with no hope of rehabilitation. We believe that each and every animal life matters.

Community Cats

In 2018, our Community Cat program worked to rescue hundreds of kittens from the field and also released 186 cats back into their outdoor homes after being altered and vaccinated. This program offers neighbor mediation, colony care counseling, food assistance, and winter shelters. If community cats are unable to be returned to the colony they came from, Brother Wolf works to place them as 'working cats' in barns, stables, or warehouses.

Transport Program

Our Transport program saved over 873 dogs, cats, and small animals in 2018. Animals from overcrowded shelters in the southeast are relocated to our partner rescues in the northeast. These rescues have a high demand for adoptable animals in their areas and communities, which provides better chances at adoptive homes for a greater number of animals. Each animal receives an interstate health certificate before travel. Our goal is to provide highly adoptable animals who would normally be killed for space in rural, southern shelters a chance to quickly find a forever home. Our transport program is an instrumental part of relieving the stress of overcrowded shelters in western North Carolina. See Part III, Ln 4c statement

Through transports, animal care, search and rescue efforts, medical care, and supply deliveries, we were able to care for approximately 500 animals.</p>
<p>No-Kill Community Development Initiative</p> <p>Brother Wolf's No-Kill Community Development Initiative exists to help some of the most impoverished areas of the Southeast cultivate community support and help to provide the resources and build the programs in each area to create their own No-Kill community with the ultimate goal of becoming their own nonprofit, animal rescue organization. In 2018, Brother Wolf had chapters in three communities outside of Asheville: Rutherford, NC, McDowell, NC, and Dickenson, VA. We provided financial support to help lay the groundwork for these lifesaving programs. Brother Wolf has continued to support each chapter in many different ways with a goal of each chapter becoming completely self-sustainable so then they can run independently of us and as their own nonprofit. Part of our strategy is to teach each chapter how to do high volume adoptions, how to recruit and train volunteers, build a comprehensive foster network, and work with individuals and businesses to cultivate financial support of the No-Kill mission. Each chapter works directly with animal control and the municipal shelters on an on-going basis to keep best informed on where the greatest need for animals in the community.</p>
